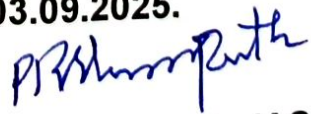
quotations were called for and IOA has received only three quotations. The EC decided to negotiate further with the tenderer and finalise the rates.
