8. To discuss the report of the committee headed by Justice B. Gokuldas about the IOA Election.

Justice B. Gokuldas Committee report was discussed in the EC Meeting in detail.

The AGM of IOA held on 22/09/2025 requested the committee under Justice B. Gokuldas to examine all the available systems of voting for IOA Election such as a Postal Ballot Paper or Digital Voting or Regional Voting and to give a report, the best system to be adopted for the IOA Election.

The report of the Committee did not speak anything about the Postal Ballot Paper or E Voting or Regional Voting. Instead, the committee suggested the existing system of voting will continue and for the adoption for Postal / Digital / Regional voting, amendments to section 15(3) of TNSR Act, 1975 are necessary.

The report did not give any suggestion for those members living in the Districts who were unable to attend the AGM during the Election time due to their age, non availability of accommodation, Travel Expenses etc.,

The committee under Justice B. Gokuldas instead of suggesting any one of the above method of Voting assumed itself as Election Advisory Committee and suggested various amendments for conducting IOA Election.

The AGM did not form the Committee as Election Advisory Committee and the amendments suggested by the Justice B. Gokul Das Committee cannot be accepted since it is against to the resolutions of the AGM.

Therefore, the Executive Committee resolved not to agree the suggestions made by the Justice B. Gokuldas Committee, since it is against the resolutions passed by the AGM. However, with more elaborate note by the Executive Committee the report may be placed in the AGM to be held on 20/09/2025.
