The President presided over the Executive Committee Meeting. He welcomed all the EC Members present.

5. The status of the Medical Health Checkup for the year 2026.

The President and the EC member Thiru. K.N.Murali have negotiated successfully with the Management of Apollo Hospitals and reduced the quoted price of Rs.5000/-per head to Rs.3000/- per head. The EC resolved to accept the offer made by the Apollo Management and decided to enter MOU with the Apollo Hospital for the following reasons: (a) Apollo Hospital has testing facilities in Chennai, Madurai, Tiruchy, Karaikudi and Karur. (b) Apollo Hospital provides Doctors'

consultation facilities based on the test results in all centres.
(c) Apollo Hospital is a reputed and well known health service provider and the test results are done using modern equipments. EC resolved that all the life members and spouses can take all the listed tests during the period from 01-5-2026 to 31-7-2026 at all Apollo Hospital centres in Tamilnadu. The EC requests all the Life members and Spouses to make use of this opportunity and take care of their health.

6. To discuss about all court cases.

- (i) Modfurn
- (ii) Income Tax

(i). The EC discussed the present status of the modfurn court case related C.S.No.528 of 2019. As IOA has got favourable judgement from the Honourable High Court, the defendant has filed an appeal, O.S.A. No. 350 of 2025 , against the favourable order issued in C.S.No.528 of 2019. The Division Bench of the Honourable High Court was pleased to grant order dated 18-11-2025, interim direction. As per the interim direction, the respondents (modfurn) were directed to deposit a sum of Rs. 6 Crores to the credit of C.S.No.528 of 2019. The matter will be posted after 8 weeks. The IOA is taking steps to list the case early. Based on the orders issued in C.S.No.528 of 2019, an E.P. was filed by IOA on 23-6-2025. The E.P.No. is 3725 of 2025 in Sr. No. 93676 of 2025 and the same is listed before the Main Master of the Honourable High Court of Madras. The EP is adjourned to 17-4-2026. The EC is following the E.P. very closely.

The IOA has filed C.S.No. 90 of 2021 to recover the rental arrears from the modfurn and others for the period from 2016 to 2020. The case is reverted back to Honourable High Court after recording necessary evidences in the Master Court IV of the Honourable High Court of Madras. IOA is taking steps to list the case early.

In O.S.No. 3352 of 2024, which was filed to recover rental arrears for the period 2020 -2022 from modfurn and others, issues have to be framed and it is to be filed in the next hearing of the case is posted on 10-4-2026.

(ii). For AY 2016-17, the IOA filed IT returns under section 11 . On scrutiny of our returns, the IT department raised a demand of Rs. 1,21,60,515 for the AY 2016-17. The IOA has filed an appeal before the Commissioner of Income Tax(Appeal), now under faceless mode. The appeal is pending for 6 long years. The IT department has been adjusting the refund amounts of Rs. 1,68,40,140/- towards the demand for AY 2016-17. The IOA has filed a WP praying for an interim direction, directing the respondent to refund Rs.1,68,40,140 due for the AYs 2011-12,2016-17,2022-23, 2023-24 and 2024-25. The WP is numbered as 13432 of 2026. A letter was handed over to Joint Commissioner of Income Tax (Exemptions) not to adjust refund amount further against the demand raised for the AY 2016-17 and our request was accepted by the IT department. The IOA will follow the WP closely.

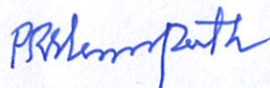
